## Areas of EH&S Involvement in the Telecommunications Arena (partial)

- Regulatory Compliance
- DOT
- Chemical exposures and MSDS accessibility requirements
- Contingent upon location, there are also possible Tribal Land considerations.
- Loss Prevention/Mitigation – Both for employees and structures
- Accident Investigation
- Pole Climbing and Pole Attachments (Owned vs. Leased and Liability Impacts)
- Equipment Inspections and Repairs (identification/training of appropriate personnel)
- Recurring Skills reviews.
- Ergonomics – both industrial and office

**There are currently 22 States and jurisdictions operating complete State plans (covering both the private sector and State and local government employees) and 4 - Connecticut, New Jersey, New York and the Virgin Islands - which cover public sector employees only.**

**States must set job safety and health standards that are "at least as effective as" comparable federal standards. (Most States adopt standards identical to federal ones.) States have the option to promulgate standards covering hazards not addressed by federal standards.**
